Candidates are advised to visit www.kveps.org and Tap on Currant vacancy Check out the adv. no. date and click "PROCEED" which will open for instructions to filling up online application form, go through the instructions, tick the checkbox and click "APPLY- (Click here to Apply)".

Candidates need to pay Application fees as prescribed after going through Payment instruction given.

Candidates are requested to upload required documents as per prescribed format and size as mentioned.

Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible / entertained after clicking the SUBMIT BUTTON. Last date of submission of online application is 30.04.2025 (till midnight).

Written Test & Computer Proficiency Test: Details of admit card download, written test & Computer proficiency test will be notified at appropriate time through newspaper and website i.e. www.kveps.org.

2. Reservation for women and all category is as per existing Govt. rules.
3. Those candidates who qualify in the written Test will be called for computer proficiency test (Practical).

(The date and venue will be notified at appropriate time through newspaper and website of Krashi Vikas Evam Paryavaran Sansthan

Society i.e. www.kveps.org.)

4. After the written test the succeeded candidates will have to bring all original testimonials i.e. Admit Card / Certificate of HSLC Examination, Mark Sheet of qualifying Examination, Computer proficiency certificate, No Objection Certificate (for those already employed), caste certificate (in case of reserved category candidates) Valid BPL Documents (for BPL opted Candidates) and Employment Exchange Registration Card.

5. Candidates willing to apply for more than one post shall have to submit separate application form and have to pay separate application fees.

6. Initially this engagement will be for three years. Based on performance and requirement of the mission's project, contract may further be extended.

7. In addition to the gross salary as mentioned above, selected candidates after joining will be entitled to get other allowances, benefits like Provident Fund, Medical Insurance, Group Accident Insurance and

performance linked incentives as per rules of the Krashi Vikas Evam Paryavaran Sansthan . They will also be entitled to get annual increment @8% of gross salary. However, these benefits are subject to change, depending upon circumstances.

8. All positions are transferable and may be posted anywhere in the State as per requirement of the Mission.

9. The short-listed candidates have to appear for a written test / interview for which no TA/DA shall be payable.

10. Incomplete application shall be rejected without giving any information and only shortlisted candidates will be called for written test and/or interview.

11. Number of posts may vary depending upon budget provision in the Annual Action Plan for the year 2025-26.
